1	<b>COURSE FEES (NON-REFUNDABLE)</b>	Rs.. 12000/- +18% GST
2	<b>DURATION OF THE COURSE</b>	1 Year Commencing from 3 <sup>rd</sup> August 2026 (6 months of training and 6 months of internship)
3	<b>STRUCTURE OF THE COURSE</b>	Posting in PFT Lab, ACTREC for training in performing and reporting Spirometry, Body Plethysmography, DLCO, and 6MWT.
4	<b>OBJECTIVES</b>	At the end of the course, the student would be able to independently perform and report Pulmonary Function Tests. Work as a Full-time PFT Technician in hospitals/Clinics/ Medical Colleges.
5	<b>EXIT EXAMS</b>	Candidates must score at least 50% in each individual theory and practical examination of the course to be considered successful.

Outstation candidate may be provided accommodation (Subject to availability) during the training period. They will have to pay accommodation charges as per institute policy.

**Terms & Condition :**

During the period of training, the trainee shall not apply for any other course/PG studies/scholarship or appear for any examination or interview outside without the permission of the center.

Any trainee leaving or remaining absent from the training before completion of this course will have to refund the amount of stipend together with interest thereon as per the rates fixed by the center. candidates whose performance in the course work is consistently found below expected standards will be terminated from the training course.

If more than 30 candidates apply for this position, a written examination will be conducted and the short listed candidates will be interviewed. Candidates will be selected based on performance in the interview.
